Cost: \$300 per student (cash, venmo, zelle or check) A 20% deposit must be paid at time of registration, balance is due on the first day of students' program.

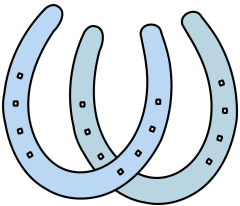
Who: Any homeschool student ages 8 and up. Exceptions can be made for younger students upon instructor approval (which will require an evaluation ride).
